Decisions required	<ol style="list-style-type: none"> 1. Secretary to ensure that Constitution and by-law changes be updated following the AGM. On going process. 2. No trip away this year. Sub-committee to start planning for next year. 3. Consider changing Championships to best 3 of 4 games in light of the very low numbers expected to play all four games this year. Present to members proposals such as having best 3 of 4 for championships or playing championships over 3 rounds 4. Seek gift cards for presentation prizes. Approach Sports Club to see if they are willing to provide gift cards for presentation instead of cash. 5. How are we going to fund the presentation now that grants do not permit purchase of food or drink? Suggest that a \$50 annual registration fee be introduced to assist with the cost of the presentation, alternatively expect members to pay for their own lunch and drinks, approach Sports Club to see if they would assist with more gift cards. 6. Introduction of member subscription and how much to charge members. Proposed an annual registration fee of \$50. Grants still to be sought for appropriate expenses. 7. Recruitment: player numbers are dwindling (for many reasons) Strategies to attract new, younger members? Ask the Sports Club if they can assist in the promotion of membership through the Club's communication methods. Encourage members to recruit new members.
